Contract Agreement

THIS AGREEMENT made the 13th January, 2019 between Assistant Engineer, Raipura Paurashava, Narsingdi of the one part and M/S Jakir Traders, Sreerampur, Raipura, Narsingdi of the other part.

WHEREAS the Employer invited Tenders for certain works, (1) Construction of a RCC Drain starting from Jonoseba Pharmacy to Culvert under Ward 05 & 04, Raipura Paurashava, Ch 0-330m, (2) Rehabilitation work of a Road Starting from Kandapara Shahid Bashirul Haque Primary School to Dana Miah's house with RCC under Ward 03, Raipura Paurashava, Ch 0-430m,(3) Rehabilitation work of a Road starting from Dana Miah's house to Hasan Ali's Moor with Bituminous Carpetting under Ward 03, Raipura Paurashava Ch 0-460m,(4) Construction of Pipe Drain Work under Ward No 01, Raipura Paurashava Ch 0-825m,(5) Rehabilitation work of a Road starting from Methikanda Sankars Dokan to Tulatuli Moor with RCC under Ward 09 , Raipura Paurashava, Ch 0-442m **Package No : IUIDP-2/RAI/P-1** and has accepted a Tender by the Contractor for the execution of those works in the sum of Taka **1,35,41,045.40 (Tk. One Crore thirty five lakh forty one thousand forty five point four only)** (which is 5% less than Engineers Estimated cost)

NOW THIS AGREEMENT WITNESS AS FOLLOWS :

1. In this agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.
2. The documents forming the Contract shall be interpreted in the following order of priority:

 - f) the General Conditions of Contract;
 - g) the General and Particular Specifications;
 - h) the Drawings, and;
 - i) any other document listed in the PCC as forming part of the Contract.
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the works and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor in consideration of the successful execution and completion of the works and the remedying of defects therein, the Contract Price of such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
